When coming to the farm to pick up lamb(s) and/or kid(s) be aware we do not allow dogs. We work closely with our Livestock Guardian Dogs to keep our farm safe. If you should decide to bring your own dogs here against our advice you choose to hold Fawnbrooke Farm and/or Conor and/or Leah Williams harmless for your bad decision.

To the best of our knowledge lamb(s) and/or kid(s) leave our farm healthy and sound, as certified by a veterinarian health certificate (if requested prior to pick up). Purchaser holds Fawnbrooke Farm and/or Conor and/or Leah Williams harmless for any injury, ailment, illness, death and/or veterinarian fees after leaving Fawnbrooke Farm. It is the purchaser's responsibility to gain the knowledge necessary to care properly for his or her animals. Fawnbrooke Farm will answer any and all questions regarding care to the best of our knowledge.

If purchaser does not complete the purchase without prior communication and arrangements, the deposit will be forfeit and the lamb(s) and/or kid(s) will be made available for purchase by another buyer. If the animals should be unavailable due to illness or death, I hold Fawnbrooke Farm and/or Conor and/or Leah Williams harmless and understand my deposit and/or any and all payments made will be returned to purchaser within 30 days of notification. This constitutes the entire understanding of the parties.
